

Canadian Automated Vehicle Initiative Unveils Bold Vision for the Future of Transportation

Ottawa, March 27, 2024 – Today marks a historic moment in the evolution of transportation as the Canadian Automated Vehicle Initiative (CAVI) is officially launched. CAVI is a new association for stakeholders in industry, all levels of government, and academia who are involved in one or more of the many aspects of the ever-expanding ecosystem for connected and automated vehicles (CAV).

CAVs are no longer only for passenger cars. They have expanded into many other market segments including robo-taxis, public transit (buses and shuttles), freight (long-distance, middle-mile, and local delivery), logistics (warehouse, ports, etc.) service and maintenance vehicles, airports, mining, and farming.

With a commitment to innovation, synergies, and sustainability, CAVI aims to accelerate the development and adoption of automated vehicles of all kinds across the country.

Barrie Kirk, CAVI's President, said "I am very excited about the launch of CAVI. There is a broad consensus that Canada needs more synergies between the different groups involved in CAVs. CAVI will be both a forum and a voice for the CAV ecosystem. Historically, Canada has been a leader in telecommunications, satellites, and many other areas. Canada can also become a leader in the CAV ecosystem."

- To provide an integrated, national perspective for the CAV ecosystem in all its many sectors.
- To provide opportunities for learning and networking through on-line and face-toface events such as conferences and a summit.
- To develop a national CAV strategy.
- To facilitate replacing silos with synergies that bring streams together.
- To promote and be a champion for the Canadian CAV ecosystem, both nationally and internationally, via the CAVI Speakers Bureau.
- To not duplicate work being performed by other organizations.
- While mindful of government policy, to say and do things that governments cannot do.
- To prepare and publish CAV Update, the CAV newsletter previously published by CAVCOE. The approach of including items of interest to many elements of the CAV ecosystem will be continued.

Who We Are

Background

Canada is doing excellent work in CAVs, but we feel that, nationally, we can do better. Twenty-nine CAV stakeholders from government, the private sector, and academia accepted an invitation from CAVCOE to a meeting earlier in 2024. The objective was to discuss whether Canada should have an organization that provides an integrated, national perspective for the CAV ecosystem in all its many sectors. A consensus said "yes". CAVI is a direct result of that meeting.

CAVI staff have been active with CAVs for ten years, including the provision of information and advice to many stakeholders.
